

Rancho Corazon @ Hipico Rate and Info Sheet

* Board - RC Hipico Santa Fe

- ⇒ Show Barn Board \$1,000.00
- ⇒ Show Barn Board Plus Monthly Supply Fee \$1,050.00

* Additional Fees

- ⇒ Vaccinations \$190.00 per vaccination
- ⇒ Partial Clip (includes mane) \$70.00
- ⇒ Full Body Clip (includes mane) \$150.00

This Includes: Grass/Alfalfa as per individual horse needs, RC branded grain mix, turnout for horses, clean stalls and shavings (daily), blanketing, treadmill or maintenance treatments (i.e. icing and theraplate).

Billed by RC: Barn supplies ordered (exception for RC Hipico horses paying extra \$50 per month), supplements, medicine, supply orders specifically for individual horse.

Billed Separately: Farrier, Veterinary & Dental Fees – these costs will be billed directly from specialist.

II.1 Training - RC Hipico Santa Fe

- ⇒ Full Training 5 days a week lessons or rides \$1,000.00
- ⇒ Part-time Training 3 days a week lessons or rides \$800.00
- ⇒ Lesson Packages
 - Lesson (trailer-in lesson or ride, lesson on horse provided by RC) \$80.00
 - 5x Weekly \$1,000.00 per month
 - 3x Weekly \$800.00 per month
 - 2x Weekly \$600.00 per month
 - 1x Weekly \$300.00 per month

III. Horse Show Fees - RC Hipico Santa Fe

- ⇒ Shipping \$.75 per loaded mile
- → Trainer Day Fee \$450 per week (will be billed as a deposit on previous month billing and non-refundable)
- ⇒ Board credit will be given in the amount of \$10/day

- ⇒ Groom Gratuity (a minimum of \$50 a week per horse)
- ⇒ Secretarial fee \$25.00 per horse/per show covers entries and mailing
- ⇒ Clients are responsible for Horse Show Expenses (stall, entries, etc.)

* The following expenses are divided by the number of customer horses showing:

- ⇒ Tack/Feed/Groom Stalls, Feed and Bedding
- ⇒ Hired Grooms, RV
- → Trainer travel and housing (Note: Trainer housing expense to be split when not staying with family)

Sales and Purchases

→ Commission 15% due on purchase of any horse of which Rancho Corazon is agent or any horse sold that is in training with Rancho Corazon.

Monthly board and training shall be paid in advance and is due on the 1st day of each month. A late charge of 18% per day is due for any payment made after 30 days past due thereafter until paid. Rancho reserves the right to adjust fees from time to time following thirty (30) days' notice to Owner. All balances due must be paid in full to release horse to owner.
